

- Meeting called to order at 7:16pm by President. N2NZD. Attendance 13
- Secretary's report read. Motion to accept by KA2PEJ, second by WA2UJX.
- Treasurer's report Checking \$1024.34, Savings \$2010.65, Total \$3034.99.

• ARES/RACES

Columbia County ARES did MS walk on May 1 with 5 members. It was a nice day and all went well. The run at CGCC only WE2G showed. FRS was used and it went well. RACES Hospital Drill on May 10, Columbia County did not activate RACES so all we could do was to check equipment. WE2G will send letter to the chairman of the Board of Supervisors about the situation. RACES has to be activated by Emergency Management personnel, while ARES does not. We may hold combined ARES/RACES nets with Greene and Ulster Counties. No report from Greene County.

• Repeater

Stan got word from Homeland Towers that they anticipate construction beginning in July. He doesn't want to do much work at the repeater site until this happens. The repeater is working. Carl, WA2UJX, was speaking with someone from Vermont, and there was interference. We are keeping the current repeater when we move to Homeland's site. They will provide the shelter, feed line, and ½ of the cost of antennas. We've only had the MTR 2000 for a year. The Yaesu/Vertex still works, but both repeaters may have PLL problems. We still need a contract with Homeland.

KC2AGM mentioned there will be a D-Star repeater going up in Greene County.

• Education

K2KGJ reported there were 6 students at the last class. They were asking good questions. Some had only been to a few classes. They are enthusiastic. Some have dropped out. Should we have exams more than once per year? We will discuss field stocking of exams at VE session.

• Field Day

Things are going fairly well. The balun from the club beam was taken from the Field Day site for repair. Nobody knows who has it. An e-mail will be sent asking for information. Len, WB2UEB, offered the use of his beam if anyone will help him take it down. Todd's trailer should handle the tower. He needs some volunteers to help move it. Todd has straps to hold the bags down. The club generator will be used. The use of 2 more laptops with Windows 7 has been obtained. We should be all right if the computers are compatible. We will run 3A or 4A. Stan will try digital if no interference. Todd will check out. Bad coax will be checked. KC2AGM will bring analyzer.

• New Business

Change proposed to By-Laws. Article 4 Section E states that new members joining the club after April 1st will be considered paid up for the balance of the current year and the following year. Membership is from January 1st to December 31st. Members who pay dues after April 1st will be paying for the following year and not have full membership for the current year.

After much discussion, it is proposed that the wording be changed to: **New members joining the club after July 1st of the current year will be charged ½ year's dues.**

Renewing members who pay after April 1 will be credited with that year's dues and will not be forced to wait to be a full member again. Their dues will again be payable on January 1 of the following year.

Meeting adjourned at 8:06. Motion by AA2Y, seconded by KA2PEJ.








THE \$110.90 PHONE JACK

It's Saturday and I just came back from Kingston Radio Shack where I was finally able to get a 1/8 inch stereo phone jack. Radio Shack sells 2 jacks for 4.99 plus tax but that's not all the cost involved in this venture. There is a bit of history I need to tell that deals with my inability to save money and time.

I purchased a CTCSS (PL tone) encoder for my Yaesu FT-221 2M transceiver. Tone encoding was not available when this radio was built so I needed to integrate the tone encoder into the transmit function. Instructions were straight forward: I needed to connect encoder lines to +6 to +15 volts, Ground, and audio to the radio. Since I wanted to be able to quickly disconnect the encoder from the radio I selected a 1/8 inch stereo phone plug to use for this purpose.




I started my hunt for parts on Friday night. Quickly finding a good used 1/8 inch phone plug but I started to become frantic when after a two hour hunt through all the used parts boxes and drawers I could not find a suitable chassis mount jack. I found mono jacks, jacks that were broken, jacks that switched, jacks that mount on PC boards, jacks that glue into the plastic cases of radios and cassette players - but not one jack that I could use. My jack needs to fit into a hole drilled through the back panel of the FT-221. OK, Let's try the garage!

Well, I store a lot of somewhat useful junk in the garage. Not wanting to throw away anything I might need someday, the garage becomes my long-term storage vault. With my trusty Phillips screwdriver and side cutter I entered the vault knowing 'something in there has a jack I can use'. After cutting apart two cassette players, an old table stereo radio and a couple of other units (and after spending about 1 hour) I tapped out. I said to myself, "I can't believe I left myself this vulnerable". I had always prided myself in knowing I had *every* and *any* used or

new part I would ever need stored somewhere on the property. Isn't that how Home Brewer's operate? Lots of STUFF to pilfer from.

So on Saturday morning I called the Radio Shack store and they said they had a package of 1/8 inch jacks available. Getting ready to leave I checked my wallet to see if I had enough cash money for the parts and trip. NO I DIDN'T. And I didn't have enough gas in the tank for the 16 mile trip. My wife had no cash left so a quick trip to the bank 4 miles away took a half hour and then a trip to a gas station to put \$20.00 in the tank was required. During the trip to Kingston I had to stop for a McDonald's meal (\$6.00) and a coffee at Dunkin Donuts (\$2.00) finally arriving at Radio Shack. Paying \$1.00 toll for the Kingston-Rhinecliff Bridge add to the cash outlay. By the time I got back to the house, I couldn't believe how much time, energy and cash it took to get this little part. I finally finished the installation and it works well.



But I added up the cash layout for the mileage, meal, the extra coffee I really didn't need, the bridge toll, the part, the time (3½ hours) and the driving around, I figure this part cost me (if I gave myself \$25.00/hour for labor and \$0.45/mile for 20 miles) at about \$110.90. Was it worth it? Sure! But I learned a lesson.... I need to store more STUFFI need more STUFF so I can save more money!

ARLB014 Senate "Companion" Bill to HR 607 Avoids Impacting Amateur Spectrum

On Thursday, May 19, Senators Joe Lieberman (ID-CT) and John McCain (R-AZ) introduced S 1040 -- The Broadband for First Responders Act of 2011 -- in the Senate. While it has a similar objective to HR 607 -- introduced in February by Representative Peter King (R-NY-3) -- this Senate bill, unlike HR 607, does not call for auctioning any portions of Amateur Radio spectrum. Both bills call for the allocation of the so-called "D block" of spectrum, 758-763 and 788-793 MHz, to facilitate the development of a public safety broadband network.

On learning in February that a Senate version of HR 607 was being drafted, ARRL Chief Executive Officer David Sumner, K1ZZ, met with staff members of the Senate's Homeland Security and Governmental Affairs Committee who were working on the bill to share the ARRL's concerns with regard to HR 607. "They seemed very receptive to our argument and appreciative of the public service contributions of radio amateurs," Sumner said. "It is gratifying to see that S 1040 avoids impacting our spectrum allocations."

Sumner explained that while some media reports are referring to S 1040 as "the Senate version of HR 607," it is important that radio amateurs not oppose S 1040: "There is no reason for us to do so. We support the creation of an interoperable broadband network for first responders. Other than to oppose any method that would impact amateur spectrum use, we do not support one method over another of achieving that objective. We only oppose one aspect of HR 607, not the entire bill."

S 1040 has been referred to the Senate Committee on Science, Commerce, and Transportation, chaired by Senator Jay Rockefeller (D-WV). Senator Rockefeller earlier introduced his own bill, S 28, to address the same general topic. Neither Senate bill would impact amateur spectrum.
