**Generator Donated to RVWARS by KE6VGT** 



The 5.5 kw Generator donated by George, KE5VGT, to RVWARS. The blue label reads: "Donated by George DePuy KE6VGT to the Rip Van Winkle Amateur Radio Society, May, 2006"

At the last RVWARS meeting at the Cairo EOC, George DePuy, KE6VGT, asked me if the Club could use a 5.5KW, 120/240Volt generator for backup at the repeater site. I said that we would discuss it and get back to him. The following weekend I contacted him and told him that we could use the generator, and made the necessary arrangements to pick-up the unit. The following weekend Stan, Marty and I went over to Greene County to pick-up the generator and transport it back to my house. The intent was to use it for Field Day and then to take it to the repeater site for backup use there during any protracted power outage. As it would be, Murphy's Law prevailed, and we were not able to use it for Field Day.

I needed to make up a cable adaptor to match the outlet on the generator (3 wire) to use with the (4 wire) 100' cable that goes from the generator to the ACPDU, and test run the generator to be sure the unit ran and was able to produce the rated output.

Time and the rain caught up with me and I was not able to complete everything that needed to be done for use at Field Day. By the time that you read this I will have finished the work and have everything ready to transport it to the repeater site. Our thanks go out to George DePuy for his generous donation of the generator to RVWARS.
